### School Description and Mission Statement

Argonne provides an academic program based on the core values of interdisciplinary teaching, multiple intelligences, and the development of creative and critical thinking. Our year round calendar provides us with time to provide enrichment activities and field study trips. Teachers meet regularly to discuss curriculum, aligning the content to standards, and implementing new strategies to enable all students to be successful. Our students celebrate likenesses and differences in the people who surround them and are proud of their own ethnic and cultural heritage.

### Opportunities for Parental Involvement

Our governance model allows for families to be involved in all of the operations of the school. Our governing committees are made up of parents and teachers. As members of our decision making processes the parents of Argonne help to determine our school's academic focus and budget expenditures. To accomplish this goal while accommodating teacher absences and professional development days, we provide permanent substitutes to STAR schools and recently implemented a new substitute system to better facilitate the placement of substitutes at all schools. The new substitute system features web and phone access - saving users' time and providing better reporting capabilities to administrators.

## **Teacher Evaluation Process**

SFUSD's teacher evaluation system is primarily based on the California Standards for the Teaching Profession (CSTP), which includes a pre-observation protocol to review the Content and Performance Standards, a teacher post-observation self-reflection opportunity and a post-observation protocol.

Administrators are trained in CSTP evidence based observations, as well as in reflective questions and coaching strategies. All of this is an effort to make teacher evaluation a professional growth-oriented process in SFUSD. For teachers who are not performing at a satisfactory level, the district has a Peer Assistance and Review (PAR) program.

The San Francisco Unified School District adopts instructional materials following the cycle of state frameworks and standards, and provides sufficient textbooks for all students to use in class and to take home in the core curriculum areas of reading/language arts, mathematics, science, and history/social studies. The following new instructional materials were adopted by the SFUSD Board of Education for the 2006-2007 school year, and were provided for all high school students enrolled in: 10<sup>th</sup> grade world history, physics, and some AP science classes. In addition, other Board-adopted core curriculum materials were provided to remedy all insufficiencies identified through a survey and other activities preceding the annual Instructional Materials Hearing at the October 10, 2006 meeting of the Board of Education. Insufficiencies exist for some high schools in the areas of health and world languages, but class sets are available. All adopted high school instructional materials have been evaluated and determined locally to meet state standards for grades 9-12. Appropriate science laboratory equipment is available for all laboratory science courses.

#### **For Elementary and Middle Schools (grades K-8)**

The San Francisco Unified School District adopts instructional materials following the cycle of state frameworks and standards, and adopts K-8 materials from the list of standards-aligned materials that have been adopted by the State Board of Education. The district provides sufficient textbooks for all students to use in class and to take home in the core curriculum areas of reading/language arts, mathematics, science, and history/social studies. For 2006-2007, new history/social studies instructional materials were provided for all students in grades K-8, and replacements were provided for core curriculum areas as identified through a survey and other activities preceding the annual Instructional Materials Hearing at the October 10, 2006 meeting of the Board of Education.

During our Academic Planning each year, we determine how we will spend our funds from the district/state/federal and our PTA. This year we are funding a reading team and math team to help our students who may need some additional help in these areas. We have a Learning Specialist Consultant, a Librarian, and Computer Paraprofessional who runs our computer lab. Students receive the services of various arts consultants throughout the year. Each class receives 2 classes a week from a Physical Education consultant. Students in fourth and fifth grade go on an overnight field study trip sponsored with funds from parents and by the PTO .

Our extended year allows the school to go further into the content themes to make connections with the real world and to make the content more meaningful for our students. In addition to the core curriculum, Argonne students take part in dance and movement, chorus, and PE. This year all students are taking part in Visual Thinking Strategies program. We are also using Step Up to Writing. Linking Council/ SSC meets monthly to plan the activities of the school, monitor our Academic Plan and budget, and to oversee any issues that may come up during the year. A teacher/ principal team plans staff meetings and professional development.

### Professional Development

The district's professional development program provides opportunities for teachers to implement the district's core curriculum for all students, update subject area expertise, use data to plan instructional improvement strategies and acquire new instructional strategies. Leadership development across content areas is facilitated centrally, and for educators and parents each school has three full days fo professional development during the academic year.
