We are also one of the magnet schools for pre-k through fifth grade hearing impaired students. Our mission statement is that we will work to develop joyful learners by providing them with support, encouragement, challenges and inspire all students to become better individuals in life. We will set high standards and will strive to help our students become responsible and respectful citizens. We will invite and encourage families in our school community to work together to make Lafayette a safe, nurturing, and successful learning environment for all.

## Section IV - School Facilities

### School Facility Conditions and Improvements

Lafayette School is in relatively good condition for being built in 1927. Numerous improvements were made in response to the American Disabilities Act lawsuit. We received a new elevator and new entrance and exit ramp from the school yard for students and adults with disabilities and the new fire alarm system is operable, but still has some mechanism problems not related to safety completed during Phase 1. We have a beautiful brand new auditorium hardwood floor replaced, remodeled boys' & girls' bathrooms, four remodeled adult bathrooms, four new ramps, sensor lights, acoustic paneling for hearing impaired classrooms, one new ADA door per classroom, library, computer lab, etc., for wheelchairs, lowered counters, ADA office desk counter and desk, water fountains, new entrance/exit doors, and new door hardware, which were completed during Phase 2 Summer 2009. Also during the Summer of 2009, we are thankful to the Public Utilities Commission (PUC) & the Miller Landscaping Co. for our school garden and to Pacific, Gas & Electric (PGE) for our solar panel. During Phase 3, Summer 2010, our school yard will be repaved with games areas distinguished with colored lines, circles and bases and some minor leaks will be addressed at on the south end of the school just to name a few.

The San Francisco Unified School District adopts instructional materials following the cycle of state frameworks and standards, and provides sufficient textbooks for all students to use in class and to take home in the core curriculum areas of reading/language arts, mathematics, science, and history/social studies. Instructional materials were adopted by the SFUSD Board of Education for the 2009-2010 school year and were provided for all high school students enrolled in advanced algebra, economics, environmental science and algebra and trigonometry classes. Class sets of health instructional materials were provided for high school health teachers. In addition, other Board-adopted core curriculum materials were provided to remedy all insufficiencies identified through a survey and other activities at the annual Instructional Materials Hearing at the October 13, 2009 meeting of the Board of Education. All adopted high school instructional materials have been evaluated and determined locally to meet state standards for grades 9-12. Appropriate science laboratory equipment is available for all laboratory science courses.

#### ***For Elementary and Middle Schools (grades K-8)***

The San Francisco Unified School District adopts instructional materials following the cycle of state frameworks and standards, and adopts K-8 materials from the list of standards-aligned materials that have been adopted by the State Board of Education. The district provides sufficient textbooks for all students to use in class and to take home in the core curriculum areas of reading/language arts, mathematics, science, and history/social studies. For 2009-2010, instructional materials were provided for all students in grades K-8. Replacements were provided for core curriculum areas as identified through a survey and other activities preceding the annual Instructional Materials Hearing at the October 13, 2009 meeting of the Board of Education.

Through the efforts of our staff and parents during our Community Meetings, we formulate our priority list for the school year based on our data to include all additional funds that we receive. We fund a physical education teacher, academic materials and computer paraprofessional to raise student achievement, challenge students, purchase computer and electronic equipment, provide additional hours for art enrichment and student advisor staff to work with our underachieving students, after school tutorial services, perceptual motors program for kindergarten students, music extended to all graders, conferences and release time for teachers, field trips, assemblies and science enrichment.

## Section IX - Student Performance

### **Standardized Testing and Reporting Program**

The Standardized Testing and Reporting (STAR) Program consists of several key components, including the California Standards Tests (CSTs); The California Modified Assessment (CMA), and the California Alternate Performance Assessment (CAPA). The CSTs show how well students are doing in relation to the state content standards. The CSTs include English-language arts (ELA) and mathematics in grades 2 through 11; science in grades 5, 8 and 9-11; and history-social science in grades 8 and 10-11. The CAPA includes ELA, mathematics, and science in grades 2-11, and for science for grades 5, 8 and 10. The CAPA is given to those students with significant cognitive disabilities which prevent them from taking either the CSTs with accommodations or modifications or the CMA with accommodations. The CMA includes ELA and mathematics for grades 3-8 and science in grade 5 and is an alternative assessment that is based on modified achievement standards. The CMA is designed to assess those students whose disabilities preclude them from achieving grade-level proficiency on an assessment of the California content standards with or without accommodations. Student scores are reported as performance levels. ### **Professional Development**

### **National Assessment of Educational Progress**

The National Assessment of Educational Progress (NAEP) is a nationally representative assessment of what America's students know and can do in various subject areas. Assessments are conducted periodically in mathematics, reading, science, writing, the arts, civics, economics, geography, and U.S. history. Student scores for reading and mathematics are reported as performance levels (i.e., basic, proficient, and advanced) and the participation of students with disabilities (SD) and English language learners (ELL) is reported based on three levels (identified, excluded, and assessed). Note: Only a sample group of California's schools and districts participate in the NAEP testing cycle. Therefore, students in any particular school or district may not be included in these results. The NAEP reflects state test results and is not reflective of either the LEA or the individual school. Comparisons of student performance on the NAEP and student performance on the Standardized Testing and Reporting (STAR) program assessments cannot be made without an understanding of the key differences between the two assessment programs. For example, the NAEP only assesses grades 4, 8 and 12 and for long-term trends assesses grades 9, 13 and 17. Additionally, the NAEP only provides state test results for grades 4 and 8. The California Standards Tests (CSTs) are based on a different set of standards than the NAEP assessments. For example, the NAEP is not aligned with California academic content and achievement standards and, therefore, does not necessarily reflect the curriculum and instruction to which students are exposed in the classroom. The NAEP assesses reading and writing separately, while the CSTs assess English-language arts (ELA), encompassing reading as well as writing conventions, spelling, and grammar. Scores on the CSTs and other assessments are not directly comparable to those on the NAEP. The averages and percentages presented are estimates based on samples of students rather than on entire populations. Finally, the questions students respond to are only a sample of the knowledge and skills covered by the NAEP frameworks.
