School Safety Plan (School Year 2008-09)

Our staff is dedicated in providing a safe, secure school and learning environment for our students. Faculty and parents worked collaboratively in developing and implementing emergency procedures. We have implemented a schoolwide conflict resolution program called the Caring School Community that places emphasis on Being Safe, Being Respectful and Being Responsible. Students are involved in classroom meetings weekly to address and problem-solve conflicts. Each child has an earthquake/emergency kit. Staff are trained on CPR/First Aid. Ulloa conducts drills on a regular basis for all emergency situations. Students and parents are surveyed annually to assess their sense of safety at school.

We have a population of 520 students in grades K-5. The students reflect the rich cultural and linguistic diversity of San Francisco. We have a huge newly renovated yard for the 1-5 graders and a separate kindergarten yard for our youngest students. We are beginning our greening project to expand our garden into the school yard. Our students take pride in their school and hence the facility is clean and welcoming. We have a full size auditorium, gymnasium as well as a large cafeteria to accomodate our students' needs.

The San Francisco Unified School District adopts instructional materials following the cycle of state frameworks and standards, and provides sufficient textbooks for all students to use in class and to take home in the core curriculum areas of reading/language arts, mathematics, science, and history/social studies. Instructional materials were adopted by the SFUSD Board of Education for the 2009-2010 school year and were provided for all high school students enrolled in advanced algebra, economics, environmental science and algebra and trigonometry classes. Class sets of health instructional materials were provided for high school health teachers. In addition, other Board-adopted core curriculum materials were provided to remedy all insufficiencies identified through a survey and other activities at the annual Instructional Materials Hearing at the October 13, 2009 meeting of the Board of Education. All adopted high school instructional materials have been evaluated and determined locally to meet state standards for grades 9-12. Appropriate science laboratory equipment is available for all laboratory science courses.

For Elementary and Middle Schools (grades K-8)

The San Francisco Unified School District adopts instructional materials following the cycle of state frameworks and standards, and adopts K-8 materials from the list of standards-aligned materials that have been adopted by the State Board of Education. The district provides sufficient textbooks for all students to use in class and to take home in the core curriculum areas of reading/language arts, mathematics, science, and history/social studies. For 2009-2010, instructional materials were provided for all students in grades K-8. Replacements were provided for core curriculum areas as identified through a survey and other activities preceding the annual Instructional Materials Hearing at the October 13, 2009 meeting of the Board of Education.

Ulloa provides many enrichment programs for our students. Our PTA funds a full-time Physical Education teacher as well as a full time Computer Teacher. The school budget provides for a Reading Specialist as well as two bilingual teacher-assistant staff. Our Art teacher, music, dance teacher, as well as our gardening teacher are funded by special grants. We are fortunate to also have a part-time nutritionist and a Learning Support Counselor at Ulloa. Our AfterSchool Learning Program is funded by the School Health program and we have 140 students currently enrolled in that program.

Standardized Testing and Reporting Program

The Standardized Testing and Reporting (STAR) Program consists of several key components, including the California Standards Tests (CSTs); The California Modified Assessment (CMA), and the California Alternate Performance Assessment (CAPA). The CSTs show how well students are doing in relation to the state content standards. The CSTs include English-language arts (ELA) and mathematics in grades 2 through 11; science in grades 5, 8 and 9-11; and history-social science in grades 8 and 10-11. The CAPA includes ELA, mathematics, and science in grades 2-11, and for science for grades 5, 8 and 10. The CAPA is given to those students with significant cognitive disabilities which prevent them from taking either the CSTs with accommodations or modifications or the CMA with accommodations. The CMA includes ELA and mathematics for grades 3-8 and science in grade 5 and is an alternative assessment that is based on modified achievement standards. The CMA is designed to assess those students whose disabilities preclude them from achieving grade-level proficiency on an assessment of the California content standards with or without accommodations. Student scores are reported as performance levels. Professional Development

National Assessment of Educational Progress

The National Assessment of Educational Progress (NAEP) is a nationally representative assessment of what America's students know and can do in various subject areas. Assessments are conducted periodically in mathematics, reading, science, writing, the arts, civics, economics, geography, and U.S. history. Student scores for reading and mathematics are reported as performance levels (i.e., basic, proficient, and advanced) and the participation of students with disabilities (SD) and English language learners (ELL) is reported based on three levels (identified, excluded, and assessed). Note: Only a sample group of California's schools and districts participate in the NAEP testing cycle. Therefore, students in any particular school or district may not be included in these results. The NAEP reflects state test results and is not reflective of either the LEA or the individual school. Comparisons of student performance on the NAEP and student performance on the Standardized Testing and Reporting (STAR) program assessments cannot be made without an understanding of the key differences between the two assessment programs. For example, the NAEP only assesses grades 4, 8 and 12 and for long-term trends assesses grades 9, 13 and 17. Additionally, the NAEP only provides state test results for grades 4 and 8. The California Standards Tests (CSTs) are based on a different set of standards than the NAEP assessments. For example, the NAEP is not aligned with California academic content and achievement standards and, therefore, does not necessarily reflect the curriculum and instruction to which students are exposed in the classroom. The NAEP assesses reading and writing separately, while the CSTs assess English-language arts (ELA), encompassing reading as well as writing conventions, spelling, and grammar. Scores on the CSTs and other assessments are not directly comparable to those on the NAEP. The averages and percentages presented are estimates based on samples of students rather than on entire populations. Finally, the questions students respond to are only a sample of the knowledge and skills covered by the NAEP frameworks.
